These "Terms and Conditions" supersede all other printed and oral statements and will be attached to and become a part of the Real Estate Sales Contract as Exhibit "A", which will prevail over this document and any other agreement between the buyer and seller.

CONDITIONS OF SALE: Dempsey Auction Company (Auctioneer/Broker) has entered into a listing agreement with Childs Fountain Investments, LLC (Seller), to offer at public auction, 14 +/-, Weiss Lake Recreational/Building Lots and Home located on Cherokee County Road 131 & County Road #595, Cedar Bluff, Cherokee County, AL.

All property, real and personal, is selling "AS IS, WHERE IS" and WITH ALL FAULTS, IF ANY" without representation or warranty of any kind as to their condition. No warranties, either statutory or otherwise, expressed or implied, including those as to the fitness for a particular use or purpose, habitability, merchantability or environmental conditions including, but not limited to, any hazardous substances, hazardous waste, petroleum or petroleum by-products concerning the property are given by the Auctioneer or Seller. Neither the Auction Company nor the Seller makes any representation concerning the property whatsoever. All bidders acknowledge and agree by their participation in the Auction, that he/she has inspected the Property and is not relying on any warranty or representation of the Seller, Auctioneer or any agent thereof. For compliance with Section 1018 of the Residential Lead-Based Paint Hazard Reduction Act of 1992, interested purchasers have had ten a (10) day inspection period prior to the auction for assessment of possible lead-based paint hazards.

All decisions of the Auctioneer will be final, including the increments of bidding, disputes among bidders, or any other issues that might arise before, during or after the auction. We require all bidders register and obtain a bidder number in order to participate in the bidding process.

The Seller has the right, at their sole discretion; to add or withdraw all or any portion of the property before the auction on Saturday, September 3rd @ 10:00 am. This property is Selling Subject to Owner Confirmation and all offers may be held open until Tuesday, September 6th @ 5:00 pm. This is a Partnership Dissolution Sale; all members of the LLC have the right to bid and will close under the same Terms & Conditions.

RESERVATIONS & RESTRICTIONS: The real estate will be sold subject to any and all Restrictions, Public Utilities, Encroachments, Zoning Ordinances, Easements, Protective Covenants as attached to the sales contract, Cherokee County Regulations, any Existing Right of Ways, and all other matters now of record. All personal property and equipment are reserved.

Also conveyed to Lots 1, 8 & OUT Parcel, is a 1/3 interest to use the boat ramp as shown on the recorded plat of Trotter's Landing recorded in Plat Book 15, Page 55, in the Probate Office of Cherokee County, Alabama.

Also conveyed to Lots 1-9, OUT Parcel & the Common Lot is a 1/11 interest in and to the 30-foot ingress/egress and utility easement as shown on the recorded plat of subdivision recorded in Plat Book 15, Page 55, in the Probate Office of Cherokee County, Alabama.

Also conveyed to Lots 10-15 is a 1/6 interest in and to the Common Area as shown on the recorded plat of Trotter's Landing recorded in Plat Book 15, Page 55, in the Probate Office of Cherokee County, Alabama, and also a 1/11 interest in and to the 30-foot ingress/egress and utility easement as shown on the recorded plat of subdivision recorded in Plat Book 15, Page 55, in the Probate Office of Cherokee County, Alabama.

PAYMENT: A 10% Buyer's Premium on Real Estate will be added to the Bid Price on all real estate today to arrive at the final purchase price. The purchaser will be required to sign the Real Estate Sales Contract and pay a non-refundable earnest money deposit equal to 20% of the final purchase price immediately following the Auction. This deposit will be held in a non-interest-bearing escrow account under the control of Dempsey Auction Co. No disbursements will be made from this escrow account until closing or otherwise in accordance with this agreement. In the event the purchaser fails to close and pay his/her balance when due, the deposit may be retained by the Seller and Auctioneer as liquidated damages in addition to any other remedies available to the Seller and Auctioneer.

ONLINE PURCHASER'S PAYMENT: At the close of the auction, successful online bidders will be emailed a sales contract package to execute and return to Dempsey Auction Co. Successful online bidders will deposit 10% of the Contract Price plus a project development fee as earnest money in the form of cashier's check or bank wire transfer with Dempsey Auction Co within 24 hours of receipt of the contract package. The entirety of the remaining balance is due at closing as stipulated in the "Terms and Conditions". Purchaser shall be responsible for all wire transfer fees. Successful online high bidders not executing and returning their contract with earnest money deposit within 24 hours of receipt will be considered in default and subject to an Administrative Fee (as defined below). All Administrative Fees are non-refundable.

DEFAULT: In the event a winning online bidder fails to submit the signed "Sales Contract" and deposit earnest money as provided in the pre-stipulated Terms and Conditions, the winning online bidder will be charged an administrative fee of \$2,500 on the credit card

provided at auction registration. Additional default remedies are reserved by Dempsey Auction Co and the Sellers as provided in the Terms and Condition & Sales Contract.

SURVEY: All the property has been surveyed for this auction by Baker Land Surveying, LLC. We are selling and conveying the (14) lots in Trotters Landing by a recorded survey in PB 15, Page 55 in the Office of Probate, Cherokee County, Alabama. A survey/staking/recording fee of \$600/Tract will be due and collected today. The accuracy of the survey is the sole liability of the surveyor and the Purchaser, and the Purchaser does hereby release the Seller and Dempsey Auction Co from all liability in all matters concerning the survey.

<u>CLOSING:</u> Closing shall take place within 30 days of auction, in accordance with the Real Estate Sales Contract, or on a date mutually agreed upon by the Seller and Purchaser(s) in writing. <u>CLOSING COSTS</u>: The Seller will provide a Limited Warranty Deed at closing, guaranteeing Good and Marketable Title. If the Seller is unable to convey clear title to the property, the Purchaser(s) Earnest money deposit will be returned.

All other costs including, but not limited to, Attorney's Closing Fees, Recording and Handling Fees, Deed Transfer Taxes, Title Search, Title Insurance, Loan Origination Fees, etc., will be the Purchaser's expense.

POSSESSION: Purchaser(s) will be granted possession of real estate at closing, on or before October 2, 2022.

TAXES: The Real Estate property taxes will be pro-rated to the date of closing. Any additional taxes assessed resulting from the change of use by the purchaser will be the responsibility of the purchaser.

AGENCY: In accordance with the Alabama Disclosure Law / RECAD, Dempsey Auction Company is acting as **agent for the seller** only in this transaction and is to be paid a fee pursuant to a separate written agreement between seller and the auctioneer.
